**The main objective of the project is** to raise the level of socio-cultural integration of 140 third-country nationals legally residing in Poland, over 18 years of age, working/studying/living in the Warmian-Masurian Voivodeship (counties: Działdowo, Braniewo, Elbląg, Iława, Nowe Miasto, Ostróda, Bartoszyce, Lidzbark, Olsztyn, Elbląg, Olsztyn), by providing them with comprehensive and individualised support allowing them to function better in Polish society.

### **TO PARTICIPATE IN THE PROJECT WE INVITE PEOPLE WHO MEET ALL THE FOLLOWING CONDITIONS:**

- ◆ age over 18,
- ◆ working and/or residing and/or studying within the meaning of the Civil Code in the area of the Warmian-Masurian Voivodeship (counties: Działdowo, Braniewo, Elbląg, Iława, Nowe Miasto, Ostróda, Bartoszyce, Lidzbark, Olsztyn, city of Elbląg, city of Olsztyn),
- ◆ third-country nationals legally residing in Poland.



### **PROJECT PARTICIPANTS WILL BE PROVIDED WITH THE FOLLOWING FORMS OF SUPPORT:**

- ◆ Analysis of problems and needs and development of an Individual Support Plan,
- ◆ Polish language courses,
- ◆ Training in Polish values and culture,
- ◆ Individual specialist support in the field of psychological counselling,
- ◆ Individual specialist support in the field of legal counselling,
- ◆ Assistant support in everyday functioning in relation to the education system, health service and other public institutions,
- ◆ Training in green skills,
- ◆ Local integration events.



## THE PROJECT RESULTS ARE:

- ✓ 28 Participants taking up education or training,
- ✓ 112 Participants improving their social situation,
- ✓ 10 people with disabilities being supported,
- ✓ 140 people from third countries/foreign origin being supported.

## AS A RESULT OF THE PROJECT IMPLEMENTATION, THE FOLLOWING OUTCOMES WILL BE ACHIEVED:

- ◆ development of an individual support plan based on diagnosed needs and possibilities,
- ◆ acquisition of language competences in the field of knowledge of the Polish language,
- ◆ acquisition of knowledge about Polish values and culture and increased awareness in the area of social aspects of life in Poland,
- ◆ assistance support in everyday functioning,
- ◆ support in resolving legal and psychological difficulties,
- ◆ acquisition of competences in the field of green skills,
- ◆ integration with Polish society through participation in local events.

## We provide, among others:

- ◆ professional coaching staff,
- ◆ interpreter support,
- ◆ reimbursement of child/dependent person care costs,
- ◆ reimbursement of travel costs to meetings for half of the Participants,
- ◆ Polish language courses,
- ◆ training in Polish cultural values,
- ◆ assistant support in everyday functioning,
- ◆ legal and psychological counseling,
- ◆ training in green skills,
- ◆ participation in local integration events,
- ◆ catering during the training.
